- \*\*The family must maintain their active status as registered parishioners through the practice of stewardship of time and talent (shared through a parish ministry) and treasure (by weekly use of the Sunday envelopes).*

I (we) agree to pay the registration fee of \$325.00 for the first Child \$305.00 for each additional child (\$250.00 per child in preschool). **I (we) understand that this non-refundable fee must be paid at the time of registration to guarantee a space for my (our) child/children and that after that time, registration will be open to new students.** (Registration fees include: Art fee \$5, Computer Lab Fee \$5, Disaster Materials Fee \$5, First in Math Fee \$10, Science Lab Fee \$5, Student Insurance Fee \$10, STAR Testing/ Technology Fee \$35, Diocesan Forms/Records Fee \$10, Student Planner \$5, Classroom Perishables/Workbooks \$150, School Handbook/Directory/Calendar \$10, and Teacher's Supply Fee \$50, Christian Action Fee \$5, in addition one per family fee of \$20.00 for PTG dues.) **Reg. Fees for first child will be due APRIL 29, 2016, Reg. Fees for each additional child will be due May 11, 2016.**
